

2020-21 SCHOOL BUDGET VOTE & BOE ELECTION

Strategic investment in resources

"Recognizing the fiscal crisis the state and many families are facing due to the Coronavirus pandemic, the proposed 2020-21 budget maintains a careful balance between program preservation while avoiding a structural financial deficit for the school system," said Superintendent Dr. L. Oliver Robinson.

Residents will vote on June 9 by absentee ballot ONLY on a proposed \$181,657,429 budget for 2020-21 that includes a spending increase of 2.21 percent (\$3,928,028).

The tax levy increase of 2.6 percent is

below the tax cap of 3.04 percent. It is based on the approved state budget. However, the Governor has indicated further cuts are pending based on availability of federal funds.

The true value tax rate is estimated to be 0.0729% (less than 1/10th of one percent). A property with a market value of \$250,000, would see a \$5 increase in the tax bill.

The proposed 2020-21 budget preserves current programs/services and supports authentic learning that is inclusive, diverse and axiomatic. A narrowly defined focus is on:

Equity in Outcomes – Address learning gaps and anticipated growth in AIS, ENL, special

education and acceleration

College Articulation Agreements -- Pathways in financial literacy and health careers

Mental Health & Wellness – Social emotional learning and restorative justice

Technology Integration to Support Virtual Learning -- Expanded access and developmentally appropriate learning management platform

Safety -- Building lock-down and communication capacity

The district will continue to strategically monitor and trim expenditures to ensure operation within a reasonable cost footprint.

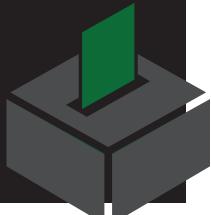
