

Shenendehowa residents will vote on May 17 on a proposed \$194,356,052 budget for 2022-23 that includes a spending increase of 3.85 percent (\$7,197,668). The tax levy of 1.87 percent is **under the New York state tax cap.**

The estimated true value tax rate would **decrease** an estimated 0.77 percent. A property with an estimated market value of \$300,000 would see an estimated **decrease** of approximately \$36 in its tax bill.


Program enhancements

Each year, there are many different budget requests for potential program enhancements. A value added perspective is used to review requests. These proposals and/or requests for funds are reviewed and analyzed based on the following factors:

- Engagement - Student voice and choice, fostering a passion for learning
- Innovation - Personally relevant learning opportunities
- Cultural Competence - Preserving equity in opportunities and outcomes
- Global Collaboration - Self-directed, civic-minded learners
- Collective Work and Responsibility - School and community partnerships

The proposed 2022-23 budget preserves current programs and services with a strategic focus on systematic opportunities to help our learners thrive in an authentic and dynamic learning environment. It provides for key program enhancements to support innovative and creative experiences in and out of the classroom. Some specifics include:

- Preserving class size at the elementary level to provide a more focused learning experience.
- Targeting investment in multi-tiered systems of supports (MTSS); connecting curriculum, instruction and assessment to support all students to success.



You are eligible to vote if you are a U.S. citizen, 18 years or older and been a Shenendehowa District resident for at least 30 days prior to the vote. No preregistration is required. Official personal identification with a photo is required at the polls. It is a crime to falsify votes (i.e. voting twice or using false identification.)

2022-23 Budget Proposal Program Enhancements (continued from page 1)

- Supporting the social and emotional needs of middle school students with the addition of a Student Support Counselor.
- Focusing on equity in outcomes for all students by adding English as a New Language (ENL) staff and an extra support personnel for Algebra 1A.
- Investing in areas of increased enrollment, including: Unified Arts, core areas of Math and Science, as well as support across all eight elementary schools.
- Expanding access with an increased investment in early education:
 - Expanded Extended Day Kindergarten (EDK) programming, move towards Full Day K;
 - 1:1 student Chromebooks for Grades 2-5; and
 - Integrative technology support with iPads for Grades K-1.
- Impactful investments to upgrade technology infrastructure, improving network resiliency and Internet redundancy.
- Investing in an obsolescence plan for an annual replacement of 2,500 student Chromebooks.
- Operational enhancements for increased reliability by upgrading wireless access points, which includes mobile displays for teachers to support dynamic learning.

Mandatory Costs

With New York State's implementation of the tax cap levy, which essentially caps school district expenditures, building a budget begins by identifying legal and contractual obligations while staying at or below the cap. These include:

- Impact in pension costs due to contribution rate changes - reduction for ERS (Employee Retirement System), -\$1,137,034, increase in TRS (Teacher Retirement System), \$659,925.
- Increase in health/dental insurance premiums, \$2,119,721.

Cost Savings

As with every budget, the district looks to offset cost increases with cost reductions. For 2022-23, this includes:

- Reduction in costs due to 15 instructional retirements (-\$779,557);
- Strategic investment with Federal dollars on one-time purchases (\$208,000), supply expenses (\$274,000), and shared services (\$681,229);
- Reduction in equipment expenses (\$407,820). ■

Seven candidates vie for three seats on the Board of Education

Three seats on Shenendehowa's Board of Education are up for election. Each seat carries a three-year term. The seats are currently held by Todd Gilbert, Robert Pressly and Deanna Stephenson. The following candidates submitted petitions with the required 56 signatures to run. Board members are unpaid and run at large. They are listed in the order that they will appear on the ballot.



Deanna Stephenson, of Halfmoon, is seeking her third term. She is employed at Fidelis Care as Director of Provider Relations. She holds a bachelor's degree in biology and forensic science from SUNY Oswego and is working towards a master's degree in health care administration from Union



Bus and Multi-Purpose Vehicle Proposition

In an ongoing effort to keep Shen's transportation and multi-purpose maintenance vehicles in safe working condition and decrease repair costs, residents will vote on a proposition that would allow the district to purchase 16 vehicles including:

School Buses

- (1) 66-passenger Type C buses
- (1) 57-passenger bus with capacity to accommodate up to 4 wheelchairs
- (4) 30-passenger buses with capacity to accommodate up to 3 wheelchairs
- (6) 30-passenger Type A buses

Grounds/Maintenance/Security Vehicles

- (1) Truck with Stow and Go Salter and Dump Body Combination
- (3) One-ton pickup with Dump Body, V-Plow, Salter

The purchase cost will not exceed \$1,677,840 of which approximately 60 percent will be reimbursed through state transportation aid, resulting in an average of 0.14 percent tax rate increase over five years. This is approximately a two cent (\$0.02) increase per \$1,000 of assessed value beginning in 2023-24. Retired buses will be sold at auction or reassigned to the facilities and operations department.

Did you know...

The district's 217 buses travel 1.9 million miles per year? Shen bus drivers participate in 75-100 hours of behind-the-wheel and classroom training before they drive students. After that, bus drivers attend up to 12 hours of training each year on various topics including student management, defensive driving, accident avoidance, disaster preparedness and first aid. All bus drivers are subject to fingerprinting, federal drug and alcohol screening, annual defensive driving tests, biennial behind-the-wheel road tests and physical performance tests. ■

On the Leading Edge of Statewide Initiatives: Equity in Opportunities and Outcomes

At Shenendehowa, we create a learning environment that acknowledges diversity, preserves equity and fosters inclusivity where the aspirations of students are prioritized, lending to an authentic sense of belonging. Students are celebrated and encouraged to stay true to themselves throughout their educational journey. Here are some key initiatives where Shen is leading the way across New York and beyond:

World Language and English Language Learner (ELL) Expansion

- With the consistent growth of ELL students across K-12, Shen has committed to add 1.6 FTE personnel, increasing English as New Learner (ENL) staff from 15 teachers to 16.6 FTE.
- Shen High School ranked first across NYS in 2021 with 236 graduates achieving the NYS Seal of Biliteracy, which recognizes high school graduates who have attained a high level of proficiency in English and one or more world languages.

Service follows need for STEM initiatives and High School Mathematics

- Providing resources in high school math, the subject area of Algebra 1A. The district is committing support of an additional 1.0 FTE staff member to meet the needs of those students in the Algebra 1A sequence of courses.
- Expansion of the STEM Club for fourth and fifth graders. Starting at Shatekon Elementary in 2018, the program has now expanded to serve students at Arongen and Okte Elementary schools.

Leading comprehensive assessment practices and graduate recognition

- Shen is a pilot district, leading the way for the NYSED Diploma Seal of Civic Readiness, giving students recognition for their achievements in Social Studies and their ability to make a positive societal impact.
- Planning for a Fall 2022 launch of a Universal Screener, which will provide data-driven assessment on the learning needs of students K-8 to make sure they have every support available to them on their learning journey.

Projected tax impact on homeowners

The following figures are based on estimated taxable assessment values (2021-22 values increased by 2.66% - five year average). Assessments are determined by the towns. Final data on assessments and equalization rates are not available to the district until August, prior to setting the tax levy and printing tax bills.

* **CONTINGENT BUDGET ASSUMPTIONS:** The contingent budget assumes no increase in the tax levy over the 2021-22 budget. Budget cuts would be pro-rated across all three component parts of the budget. Non-contingency items would be removed including: student supplies, community use of facilities, certain equipment purchases and certain non-contractual salary increases. In addition to this limitation, the percentage of the administrative component for the contingency budget cannot be greater than the percentage from the previous year.

Estimated Basic STAR Exemption Savings

Average Basic STAR Tax Savings for 2022-23 Budget Proposal is \$602.

Maximum Allowable Tax Levy Limit

Using a complicated 8-step formula developed by the Office of the State Comptroller, Shen's 2022-23 maximum allowable tax levy limit is 4.29 percent. The proposed 2022-23 budget is under the NYS tax cap at 1.87%.



Who can vote?

No pre-registration is required but official personal identification with photo is required at the polls. It is a crime to falsify votes (i.e., voting twice, or using false identification).

Can't get to the polls?

Absentee ballots may be used by any resident who will not be available to come to the campus to vote. They are available at the district office, 5 Chelsea Place, Clifton Park. For information, call the district clerk at 881-0623. By law, absentee ballots are mailed to any resident who is certified by Saratoga County as disabled. If you are disabled and did not receive one, please call the district clerk's office. Ballots must be returned to the district clerk no later than 5 p.m. on May 17.

Directions to the polls

Gowana Middle School is located on Shen's main campus. Enter the campus using the Route 146 entrance and then bear left. Gowana is on the right.

What's on the ballot?

Proposition 1

A \$194,356,052 million budget for 2022-23 that includes a spending increase of 3.85 percent (\$7,197,668). Proposition 2

Authorize the purchase of buses and multi-purpose maintenance vehicles at an estimated aggregate cost not to exceed \$1,677,840.

Proposition 3

Three seats on the seven-member Board of Education are up for election. Each seat carries a three-year term. The last incumbents are Todd Gilbert, Robert Pressly and Deanna Stephenson. The candidates with the plurality of votes shall be declared elected.
