Shenendehowa residents will vote on May 16 on a proposed \$206,611,477 budget for 2023-24 that includes a spending increase of 6.31% (\$12,255,425). The tax levy of 2.72% is <u>under the New York state tax cap of 3.15%</u>. The estimated true value tax rate would increase by an estimated 0.70%. A property with an estimated market value of \$300,000 would see an estimated increase of approximately \$32 in its tax bill.

SCHOOL BOARD ELECTION

Two seats on the Board of Education are up for election. Each seat carries a three-year term. The seats are currently held by Naomi Hoffman and Gusta Miller. The incumbents are running unopposed.

Program enhancements

Each year there are many different budget requests for potential program enhancements. A value-added perspective is used to review requests. These proposals and/or requests for funds are reviewed and analyzed based on the following key factors:

- Engagement Student voice and choice, fostering a passion for learning
- Innovation Personally relevant learning opportunities
- Cultural Competence Preserving equity in opportunities and outcomes
- Global Collaboration Self-directed, civic-minded learners
- Collective Work and Responsibility School and community partnerships

The proposed 2023-24 budget preserves current programs and services with a strategic focus on the needs of all students. It provides key program enhancements to provide innovative and creative experiences in and out of the classroom, as well as services that support student safety and well-being. Some specifics include the following:

- Creating a Middle School theater program, expanding modified sports and extra-curricular options to enhance engagement.
- Expanding contractual services with Saratoga Center for the Family to provide additional mental health supports.
- Providing additional academic supports at the Middle School for students struggling in ELA.
- Additional special education staffing at the Elementary School Level to meet growing needs.
- Expansion of Health Science course options at the High School.



You are eligible to vote if you are a U.S. citizen, 18 years or older and have been a Shenendehowa **District resident** for at least 30 days prior to the vote. \$55 million Capital Project - Early Learning Center Addresses Key District Needs

On May 16, residents will be asked to vote on a Capital Project Referendum to renovate the donated facility at 5 Maxwell Drive into an Early Learning Center. The authorization is not to exceed \$55 million borrowing. State Building Aid and Capital Project Reserves will be used to offset the impact on taxpayers.

With the use of \$3 million dollars in reserve funds, a 30-year bonding spread for the smoothing of debt, and approximately \$25 million in State Building Aid, it is estimated that the tax impact of this project will be approximately twenty-five cents (\$0.25) per \$1,000 of tax assessed value per year.

The district will apply for Kindergarten transition aid to offset operating costs. The district will also assess how changes to state funding for Universal Pre-K can be used to support the operations of applicable classes.

5 Maxwell Drive, a property donated to the district by Don and Beverly Greene & Family, is a 150,000-square-foot building, of which 110,000-square-feet will be completely gutted and renovated in accordance with New York State Education Department facilities/building standards. This facility will become an Early Learning Center that answers the district's need for space to accommodate full-day Kindergarten. This center will accommodate over 700 children and will also house alternative education programs and allow for the centralization of district operations.

The goals of this project include:

- Providing upwards of 42 classrooms for Kindergarten and potentially pre-K purposes.
- Expanding capacity for alternative education programming, from tutoring to special education, to college collaborations.
- Consolidating various district operations and warehouse storage, yielding cost savings and increasing efficiency.

This building is a major asset to the district. The Early Learning Center will be the equivalent of almost two elementary schools combined.

There are many additional advantages (economies of scale) to consider with this proposition as well. These include, but are not limited to:

- Minimizing or eliminating certain recurring operational costs (ex: warehouse lease expenses \$135,000 per year).
- Freeing up 24 additional classrooms between the eight elementary schools, reducing congestion and allowing for future growth.
- Repurposing office spaces at the Middle and High Schools for classroom use.
- Potential proceeds from the sale of the existing District Office.

Two Candidates vie for Two Seats on the Board of Education

Two seats on Shenendehowa's Board of Education are up for election. Each seat carries a three-year term. The seats are currently held by Naomi Hoffman and Gusta Miller. The following candidates submitted petitions with the required 89 signatures to run. Board members are unpaid and run at large. They are listed in the order that they will appear on the ballot.



Naomi Hoffman, of Clifton Park, is seeking her third term on the Board of Education. Currently, she is the co-founder and CFO of Mountain Dog Running, LLC. She also has 20+ years of private and public experience in accounting, finance, and audit through

positions held with Kitware Inc, the NYS Teachers' Retirement System, and the NYS Comptroller's Office. She holds a BS degree in Accounting and an MBA with a concentration in Management Information Systems, all from SUNY Albany. She and her husband, Bill, are proud parents of two Shenendehowa graduates.



Gusta Miller, of Clifton Park, is seeking her third term on the Board of Education. Prior to moving upstate, she formerly had a psychotherapy practice in Manhattan. Gusta has both her undergraduate and graduate degrees from New York University and post-

graduate degree from the Institute of Contemporary Psychotherapy. Gusta and her husband, Jeff, have two children. Their oldest graduated from Shenendehowa in 2022, and the younger currently attends Shen.

Restorative Practices

Over the next several months, staff from across the district will engage in training to learn more about implementing Restorative Practices in schools. Restorative Practices focus on relationships and community. When used proactively, Restorative Practices can improve school climate and culture. When used as an alternative to traditional disciplinary practices, it focuses on repairing harm and restoring relationships.

Shen counselors have used restorative circles for the past several years as a way to build community within classrooms. In a community circle, students have the opportunity to share openly about a chosen topic, guided by a staff member. Shen administrators can implement Restorative Practices to prevent and/ or resolve conflict between students, with a focus on repairing relationships and preventing recurring problems between the same students. Restorative Practices provide a powerful framework for building and sustaining healthy relationships.

College in the High School

Did you know that Shenendehowa High School will soon offer nearly 50 college credit bearing courses?

Shen students are able to earn college credits in a variety of subject areas while still in high school at a significantly reduced cost.

Starting in the 2023-2024 school year, Shen will offer expanded opportunities for students to take College in the High School courses through Hudson Valley Community College. HVCC courses taken at Shen have significant benefits for students and families:

- Courses are taught by Shen teachers.
- Tuition is up to 90% less expensive than local public or private colleges at \$67 per credit.
- Students who qualify for free or reduced lunch receive a full tuition scholarship.
- HVCC credits transfer to all SUNY colleges and universities (and many non-SUNY schools), depending on major and GPA.

Bus Purchase Proposition

In order to act in accordance with the New York State mandate to purchase electric buses, fully converting the bus fleet to zeroemission buses by 2035, and in an ongoing effort to keep Shen's transportation vehicles in safe working condition and decrease repair costs, the district has put forth the following proposition:

- (4) Electric School Buses
- (1) Level-3 Charger for the Shop
- (5) 28-Passenger Type "A" buses

The purchase cost for all of the items listed above will not exceed \$2,450,646, of which approximately 60% may be reimbursed through state transportation aid, resulting in an average of a 0.19% tax rate increase over five years. This is approximately a three cent (\$0.03) increase per \$1,000 of assessed value beginning in 2023-24. Retired buses will be sold at auction or reassigned to the facilities and operations department.

Did you know...

The district's 217 buses travel 2.1 million miles per year. Shen bus drivers participate in 75-100 hours of behind-the-wheel and classroom training before they drive students. After that, bus drivers attend up to 12 hours of training each year on various topics, including student management, defensive driving, accident avoidance, disaster preparedness, and first aid. All bus drivers are subject to fingerprinting, federal drug and alcohol screening, annual defensive driving tests, biennial behind-thewheel road tests, and physical performance tests.

Setting Goals that Create a Learning **Environment Where All Can Excel**

At Shenendehowa, our focus is on the students and how we can create the best outcomes for them and their education. We've set key goals in areas of Organizational Culture and Environment, School and Classroom Experiences, Personnel and Professionalism, and Fiscal Responsibility. Here are just a select few ways that we are reaching some of our goals, focused on continued improvement:

Organizational Culture and Environment

- Onboarded Behavioral Specialist in Elementary School focused on students in crisis, providing supports for students not identified as needing special education.
- Implemented the multi-tiered system of supports (MTSS) to help address both the academic and social emotional needs of students.
- Addition of a student support counselor at the Middle School Level to address social emotional needs of identified students.
- Enhanced safety protocols and the ability to identify potential online threats, and respond effectively.

School and Classroom Experiences

- Enhanced literacy teaching methods through targeted professional development at the Elementary School level, using data to drive targeted instruction.
- Used Shen Learning Framework to better activate student learning at the Middle School Level.
- Continued focus on equitable grading practices, bias-resistant and motivational grading practices.
- Expansion of college credit-bearing courses at the High School Level.

Personnel and Professionalism

- Continued focus on recruiting, hiring, retaining a diverse workforce, and cultivating a strong candidate pool.
- Systematized professional development offerings for both instructional and non-instructional personnel.
- Succession planning and cross-training to proactively preserve organizational viability.

Fiscal Responsibility

- Used Federal COVID funds to expedite purchasing of instructional resources and upgrading instructional technology.
- Made changes in Medicare and drug plans to yield millions in current savings and future cost containment.

Projected tax impact on homeowners

The following figures are based on estimated taxable assessment values (using the five year average). Property assessments are determined by the towns. Final data on assessments and equalization rates are not available to the district until August, prior to setting the tax levy and printing tax bills. These are merely estimates of the potential impact.

* CONTINGENT BUDGET ASSUMPTIONS: The contingent budget assumes no increase in the tax levy over the 2022-23 budget. Budget cuts would be pro-rated across all three component parts of the budget. Non-contingency items would be removed including: student supplies, community use of facilities, certain equipment purchases and certain non-contractual salary increases. In addition to this limitation, the percentage of the administrative component for the contingency budget cannot be greater than the percentage from the previous year.

Can't get to the polls?

Absentee ballots may be used by any resident who will not be available to come to the campus to vote. They are available at the district office, 5 Chelsea Place, Clifton Park. For information, call the district clerk at 881-0623. By law, absentee ballots are mailed to any resident who is certified by Saratoga County as disabled. If you are disabled and did not receive one, please call the district clerk's office. Ballots must be returned to the district clerk no later than 5 pm on May 16.

Directions to the polls

Gowana Middle School is located on Shen's main campus. Enter the campus using the Route 146 entrance and then bear left. Gowana is on the right. Follow the signs to the entrance of the polling place.
